


The DUT Partnership


- A public-public partnership, co-funded by 27 European countries and the European Commission

Positive Energy Districts (PED)

Positive Energy Districts as a tool for cities to address the urban energy transition and climate-neutrality, aiming at


- improving energy security by decentralizing fossil-free energy generation,
- reducing energy demand and providing energy efficiency solutions,
- active interconnection with the regional and national energy systems.

The PED concept follows a holistic approach, combining technological with system and social innovation, with a strong focus on local communities, quality of life and links to greening strategies.

The PED Pathway will initialize 100 PEDs in Europe by 2025 and contribute to the mission on climate-neutral cities with a portfolio of PED solutions until 2030.

PED Priorities

- Aim for high share of locally generated renewable energy
- Energy communities for energy sharing and trading and digital steering of energy use
- Provide and integrate facilities for energy storage
- Reduce energy demand and implement energy efficiency measures
- Interconnect buildings and infrastructure through energy flows between them
- Actively manage energy flexibility and interconnection with the regional energy system




Circular Urban Economies (CUE)

The CUE Pathway operates from the assumption that urban areas should be understood and addressed with respect to their resource use and socio-economic preconditions.

It aims to foster the design of urban places characterized by regenerative urbanism: liveable, inclusive, and green communities that are sustained by circular resource flows.


The CUE TP will provide a portfolio of 50+ solutions that can contribute to the circular transformation of urban areas until the end of the partnership.

CUE Priorities

- Urban food systems rely on local and regional circular loops
- Construction materials re-used locally and buildings are refurbished and retrofitted
- The city as an enabler of biodiversity
- Resources and tools are shared and maintained locally
- Buildings and infrastructures are climate-proofed
- Blue-green infrastructure are designed to function on nature-based principles





15-minute City (15mC)


The 15mC Pathway aims at rethinking the urban system holistically to encourage sustainable mobility and transport choices and allocate urban space for integrated neighbourhoods.

It recognises different urban contexts, focuses on transferability and accounts for the diversity of contemporary urban lifestyles to boost action towards climate-neutral, liveable and inclusive cities as a whole.

The 15mC Pathway will built up an Innovation Portfolio and deliver tested experiences and practices of 50+ solutions until the end of the partnership, which have demonstrated high potential for an encompassing urban mobility transition.



Call structure

Transnational Part (2 Stages)

Stage 1: Pre-proposal

Submission of a pre-proposal, including a concise project description as well as a description of the partners. If the pre-proposal is selected, the project consortium is invited to submit a full proposal.

Stage 2: Full proposal


Submission of a full proposal, only if the pre-proposal is invited to participate in Stage 2.

National/Regional Part

- All project partners will be evaluated according to national/regional eligibility criteria and requirements.
- **Important!** Some Funding Agencies require submission of a proposal on national/regional level. See the respective national/regional requirements for more information.

Transnational project structure

Who can apply

Research organisations: Higher education institutions including universities, university colleges; research institutes or other entities with research undertakings;

Urban government authorities such as regional and local government institutions, municipalities and municipal organisations, city authorities, urban public administrations, and infrastructure and service providers;

Companies and commercial organisations;

From the culture and creative sectors, e.g., artists and designers

Consumers and civil society representatives such as local and community organisations, non-governmental organisations, not-for-profit organisations, citizens' representatives;

IMPORTANT!

Please be well aware that not every Funding Agency in every country may fund every organisation type. Organisation types that can be funded may also differ for research types, pathways and even topics in one country or region. When building a consortium pay attention to table 1 in Annex A and the information listed for each country in the Annex A.

Partnering support

The DUT Call requires project consortia from at least

- three independent legal entities, applying for funding from
- three different countries that have Funding Agencies participating in the call;
- two eligible Applicants within the consortium must be from different EU Member States or Associated Countries eligible for EC co-funding for this Call

Picking partners for your proposals

- In stage 1 all pre-proposals will undergo an evaluation by independent experts, after which a ranking list will be established based on the evaluation criteria (see call text).
- Apart from excellence according to the criteria, the most important factor for proposals to be successful in the pre-proposal phase is the availability of sufficient budget at the funding agencies responsible for the respective partners.
- Based on the ranking list, only those projects will be invited to stage 2, who are within an oversubscription rate of approx. three times the budget of the funding agencies involved.
